

Patients' Guide to Uninsured Services

Some of the services you request from your family physician are NOT covered by OHIP. The fees listed below are based on the Ontario Medical Association's suggested rates as per the January 2022 OMA Physician's Guide to Uninsured Services.

Fees will always be discussed with you before the uninsured service is provided. All uninsured services must be paid in full when rendered, and a receipt will be provided. Should you be unable to pay at that time, please speak with our office staff and/or your family physician to discuss payment options for settling your account.

When requesting forms to be completed, please ensure that all patient portions of the form are completed, signed and dated (e.g. consent for release of medical information) BEFORE dropping off the forms. Thank you for your cooperation.
